Delegations

Therrien Botting and Oshea Jephson, Yukon Government Highways and Public Works (HPW)

- HPW has begun a public engagement on a new Motor Vehicles Act. There is an Open House in Tagish on May 16th.
- HPW is one year into the project. Expected timeline: 2 years to prepare an Act to table; 4 years to table 18 regulations. Goal is to completely replace Act and regulations. HPW is looking at all jurisdictions
- Yukoners are encouraged to fill out an online survey by May 31:

- What we heard document will be produced
- Municipalities, First Nations will get to see draft proposals during the final stage of engagement – in 1 or 1.5 years
- 7 main themes: licensing, fees and fines, road safety, vehicle safety and condition, enforcement technology, ORVs and snowmobiles
- LACs are “targeted stakeholders”
- There was a discussion about motor vehicle issues in Tagish. Boyd raised the issue of prevalence of cracked windshields in rural Yukon, and not setting a standard for vehicle inspections, emissions, windshields that will hurt people in rural Yukon. Therrien said they were hearing a lot about abandoned/beater vehicles. Boyd wondered about tying fines to other pieces of legislation (eg. child support)

May 16 Motor Vehicle Act Open House (5-7pm)

- With discussion with TAC, the time changed from 5-9pm to 5-7pm
- TAC to use Mailchimp send out ad and link to survey site.
- Procurement team also attending and talking to Tagish residents about doing business with Yukon Government

RCMP Monthly Report (JP Cormier)

- No April report prepared yet
- Pretty quiet last few weeks. One speeding ticket on the Carcross side

- New focus for detachment: traffic, community policing, restorative justice
- No criminal charges in Tagish this winter. There was a theft in the fall
- There was a discussion of drugs in Carcross, which continues to be a big issue, and a discussion about cannabis legalization
- There is potential RCMP staffing changes over the summer
- Train starting up from Skagway (more traffic could be coming up)
- Long weekend coming – some discussion of parties past. Dry spring; Cheryl will be watching for fires
