Emergency status: a state of emergency was declared on March 27, 2020. It was extended for another 90 days on June 12, 2020.

Health care

- Outdoor visits for long-term care residents are now permitted.
- To help Yukoners at risk during this pandemic, vulnerable populations can now access [mental health and social supports online](#).

Travel and borders

- The Government of Yukon will resume offering regular road tests as of July 2 as Yukon enters Phase II the plan for lifting COVID-19 restrictions.
- Starting July 1, residents of British Columbia and Yukon will be allowed to travel back and forth without the need to self-isolate for 14 days. Residents of the Northwest Territories and Nunavut will also be allowed to enter Yukon: <https://yukon.ca/en/news/june-24-2020-covid-19-update>
- The Government of Canada will now require temperature screenings for all passengers travelling to and from Canada: <https://www.canada.ca/en/transport-canada/news/2020/06/temperature-screening-to-be-required-for-travellers-at-canadian-airports.html>
- Canada and the U.S. have extended the current border measures until July 21, keeping borders closed to non-essential travel.
- Territorial campgrounds are open with some restrictions: www.Yukon.ca/camping

- Anyone entering Yukon must check in with an Enforcement or CBSA Officer and provide their destination, contact information, and declaration.
